County Comprehensive Plan, and all other provisions of the Land 27 28 Development Code.

5 1.5262 The property affected by the change of zone is adequate in size 1 2 and shape to facilitate those uses that are normally allowed in 2 conjunction with such zoning. 3 4 The property affected by the proposed change of zone is 3. properly related to streets to adequately serve the type of traffic 5 generated by such uses that may be permitted therein. 6 7 4. The proposed change of zone will have no adverse affect on the appropriate use and development of abutting properties. 8 9 The granting of this Zone Change is consistent with 10 the goals of the LCDC. 11 6. The granting of this Zone Change is subject to the follow-12 ing condition: 13 CONDITION: 14 a. There shall be no use allowed under this Zone Change until the owner first submits in writing to the Klamath County 15 Planning Department a statement setting forth what the use will 16 l be as well as a plot plan showing that all relevant provisions of 17 the Land Development Code, with regard to parking, setbacks, etc., 18 19 will be complied with. 20 FINDINGS OF FACT: 21 The requested Zone Change has been granted with the above 22 condition based on the following findings of fact: 23 The applicant makes this request to change the zone of the property in question from Rural Community Residential to 24 Highway Commercial. The purpose of the Highway Commercial zone 25 26 is to provide commercial services and goods in places conveniently 27 and safely accessible to highways. 28 The property in question is approximately 3.1 acres and ZC 1-84 Page 2

rectangular in shape. It is generally located between State 1 2 Highway 97 and the Southern Pacific Railroad, and located at the 3 north and south of Fourth Street in the town of Chemult, Oregon. The surrounding area is predominantly commercial or 4 3. industrial zoning, and, therefore, the requested change should 5 not have significant effects beyond the immediate area. 6 7 4. The site is within the Chemult Fire District with the fire hall being in the town of Chemult. 8 9 No one testified in opposition to the granting of this 5. Zone Change, and there was no evidence presented that there would 10 11 be any adverse effects on the appropriate use and development of 12 abutting properties. 13 The Hearings Officer, based on the foregoing Findings of 14 Fact, accordingly orders as follows: 15 That real property described as 16 "being generally located between State Highway 97 and the Southern Pacific Railroad; and located north 17 and south of Fourth Street in the town of Chemult, Oregon," 18 is hereby granted a Zone Change from Rural Community Residential 19 20 to Highway Commercial.
