Reference is made to that certain trust deed made by LAWRENCE S. SAMANTE, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., as beneficiary, dated July 22, 1978, recorded September 19, 1978, in the mortgage records of Klamath County, Oregon, in volume No. M-78 at page 2517, covering the following described real property situated in said county and state, to-wit:

Lot 22, Block 29, Tract No. 1113, OREGON SHORES, UNIT #2, in the County of Klamath, State of Oregon.

By this beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed, and a notice of default has been recorded pursuant to Section 86.745(3) of Oregon Revised Statutes, the default for which the foreclosure is made is grantor's failure to pay when due the following sums:

Monthly installments of principal and interest beginning with May 17, 1983, and subsequent monthly payments of \$60.07 each due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all obligations secured by said trust deed immediately due and payable, said sums being the following to-wit:
