This deed is made this <u>3rd</u> day of <u>May</u> 1984, between THOMAS H. DURYEE, Sheriff of Klamath County,

Oregon, grantor, and WESTERN BANK, grantee. WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamath County between Western Bank, plaintiff, and G. ROBERT LECKLIDER, NANCY C. LECKLIDER, DOUGLAS M. FELLOWS, P.C., and JOSEPH J. McCARTHY, P.C., being Klamath County Circuit Court Case No. 83-430 CV, a judgment and decree was entered on October 26, 1983, for the foreclosure of the mortgages

on the real property described below; and WHEREAS, this court thereafter issued a writ of execution and pursuant thereto on December 27, 1983, all of the interest of the defendants G. WHEREAS, more than sixty (60) days have elapsed since the date of the sheriff's sale of the real property described hereinafter; and said real property has not been redeemed from the sale, and the grantee herein is the rightful owner and holder of the certificate of sale and has caused the certificate to be delivered to the grantor; and

WHEREAS, on <u>May 2, 1984</u>, 1984, the Circuit Court of Klamath County, Oregon ordered that the Sheriff of Klamath County forthwith execute a deed of conveyance to Western Bank of the real property described herein;
