PURSUANT TO SECTION 702(d) OF THE BANKRUPTCY CODE  
and  
ORDER AUTHORIZING DEPOSIT OF FUNDS

IT IS HEREBY ORDERED that W CHAPMAN WOOTEN  
of 842 Park Lane, Henderson, Nevada 89015, is hereby appointed as interim  
trustee of the estate of the above-named debtor.

The amount of the bond is fixed at \$50,000 Blanket Bond.

The interim trustee so appointed is directed to file his/her acceptance or  
rejection within five (5) days from the date hereof.

IT IS FURTHER ORDERED, pursuant to Section 702(d) of the Bankruptcy Code,  
that if a trustee is not elected under subsection (c) of Section 702 of the  
Bankruptcy Code at the meeting of creditors under Section 341 of the Bankruptcy  
Code, then the interim trustee shall serve as trustee in this case.

The amount of the bond of the trustee is fixed at \$50,000 Blanket Bond.

THE FOLLOWING PARAGRAPHS DO NOT APPLY TO THE DEBTOR

IT IS FURTHER ORDERED that the above-named trustee is hereby authorized to  
deposit into a checking account, savings account, or Time Certificate of  
Deposit, any and all funds received as assets in the above-entitled proceeding.

IT IS FURTHER ORDERED that any and all disbursements made by the Trustee  
from such checking account or savings account shall require the signature of the  
following: The Trustee and Patricia Gray-Edwards, Clerk of the U.S.  
Bankruptcy Court.

IT IS FURTHER ORDERED that any renewal of a Time Certificate on Deposit  
shall be authorized without signature, but that any disbursement from a Time  
Certificate on Deposit shall require the signature of both the Trustee and  
Patricia Gray-Edwards, Clerk of the U.S. Bankruptcy Court.
