Reference is made to that certain trust deed made by LEROY I. LAUNDER, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, An California Corporation, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., An California Corporation, as beneficiary, dated March 15, 19 79, recorded May 30, 19 79, in the mortgage records of Klamath County, Oregon, in book/reel M-79 at page 12395, covering the following described real property situated in said county and state, to-wit:

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes: the default for which the foreclosure is made is grantor's failure to pay when due the following sums:

monthly installments of principal and interest beginning with July 15, 1982 payment, and subsequent monthly payments of \$80.35 each and assessments due in the amount of \$144.00; and subsequent installments due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all obligations secured by said trust deed immediately due and payable, said sums being the following, to-wit: R4,983.46 with interest thereon from June 15, 1982, at the rate of EIGHT AND ONE-HALF (8½%) per cent per annum until paid, and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Trust Deed.
