**TRUSTEE'S NOTICE OF SALE**  
Reference is made to that certain trust deed made by LEROY LAUNDER, as grantor, to TRANSAMERICAN TITLE INSURANCE COMPANY, an California Corporation, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., an California Corporation, as beneficiary, dated March 15, 1979, recorded May 20, 1979, in the mortgage records of Klamath County, Oregon, in book No. M-79 at page 12395, covering the following described real property situated in said county and state, to-wit:
