LAST WILL AND TESTAMENT

I, LEWIS H. ROBINSON, being over the age of twenty-one years, and being of sound and disposing mind and memory, and having in mind the natural objects of my bounty, and not acting under the duress or undue influence of any person whomsoever, and desiring to make a final disposition of my property, do hereby declare and publish this document as my Last Will and Testament.

FIRST. I hereby revoke any and all wills, codicils and testamentary dispositions heretofore made and executed by me.

SECOND. I direct that the expenses of my last illness, my funeral and the disposition of my remains be paid first; and I direct that my Executrix shall make the arrangements for my funeral and the disposition of remains. My burial shall be at the New Cemetery in Brookings, Oregon.

THIRD. I direct that my just debts, if any there be at my death filed against my estate, together with the expenses of administering my estate, shall be paid next.

FOURTH. I hereby empower my Executrix to lease, encumber, sell, exchange, or otherwise deal with, manage, or dispose of, all or any part or portions of my residuary property, real, personal or mixed, which is to say, all that property not specifically devised or bequeathed herein or by codicil at such time, and upon such terms and conditions as my Executrix shall in her sole judgment, deem to be in the interest of my estate, such sale or other action to be a public or private sale or transaction, in the sole judgment of my Executrix, without any reference to the order of disposition of property, and without necessity for any petition, citation, hearing, order, or any other action of any kind.

FIFTH. I further authorize my Executrix in the exercise of the powers hereinabove granted, to hold, manage, and operate any and all businesses or properties in my estate, as she shall in her sole judgment deem to be fit and proper, all at the sole risk of my estate and not otherwise, with the profits and losses therefrom to inure or be chargeable to my estate as a whole.

SIXTH. I direct that my Executrix treat as an obligation of my estate and to pay, without any apportionment thereof, all estate, inheritance or other death taxes or duties imposed and made payable by reason of my death by the laws of the United States, or of any state, territory or country. If any such tax or duty be paid by any other person, I direct my Executrix to reimburse such person for payment of the same.

SEVENTH. I hereby declare that my only children, whether living or dead, natural or adopted, are the following: WILLIAM LEE ROBINSON, GLENDA MARCHANT and RANDY RAY ROBINSON.

NINTH. I hereby appoint my wife, ~~EILEEN M. ROBINSON~~, as Executrix of this, my Last Will and Testament, and I direct that said Executrix serve without bonds. In the event said Executrix shall decline or be unable to serve as such for any reason whatsoever, then I appoint WILLIAM LEE ROBINSON as Executor, to serve without bond, to have and enjoy all of the powers herein granted to my primary Executrix, including, but not limited to the powers set forth in paragraph Fourth above.
