THIS AGREEMENT made this 20th day of April, 1984, between YONNA VALLEY RANCH, an Oregon partnership, and or its assigns, hereinafter referred to as "Grantor," and EAST OREGON CATTLE COMPANY, an Oregon business trust, and or its assigns, hereinafter referred to as "Grantee."

WITNESSETH:

Grantor grants and conveys to Grantee exclusive hunting and fishing rights on all property of the Grantor including all State leased and BLM leased land under lease to Grantor and any other BLM or State land Grantor may lease which adjoins said property, description of which is filed and known as the Horton Place(3200 a. deeded, 1700 a. BLM leased and 240 a. State leased), and the Hunt Place (880 a. deeded). Grantee will have said exclusive hunting and fishing rights for a period of 15 years, commencing September 1, 1984, and expiring September 1, 1999.

In consideration of said transfer of the exclusive hunting and fishing rights, Grantee shall pay Grantor \$5,000 in May, 1984 (which will pay up to September 1, 1994) and \$5,000 in November of 1984, (which will pay up to September 1, 1999).

Grantee will furnish a list of all persons who are eligible to hunt or fish on said leased land and show applicable dates.

Grantee and guests will have access to all roads and trails on said leased land for use of with motor vehicles and/or horses.

Continued

It will be Grantee's responsibility to keep all gates closed at request of Grantor.

Grantor grants to Grantee the right to maintain a landing strip on Yonna Valley Ranch in an area of the Grantee's choice, and Grantee agrees not to place said strip any closer than 1/4 mile to the main ranch buildings. Grantor may also use said landing strip.

Grantee shall have use of corrals and small pasture for no more than four horses during the hunting season.

Grantee agrees to flood, at the request of Grantee, areas used to hunt at the expense of the Grantee.

This lease shall be recorded and will run with the property owner's heirs and assigns when sold or not sold, and all rights to Grantee will remain in full force and effect to its heirs and assigns.

Should Grantor sell said land, Grantor will provide Grantee with certification that the new purchaser has been advised of this hunting and fishing agreement in its full content.

It shall be the Grantee's responsibility to post said property and Grantor shall maintain all signs as posted, and names of all trespassers shall be turned over to the proper authorities.
