

BARGAIN AND SALE DEED

JOSEPH E. JOHNSON, Grantor, hereby conveys to JOSEPH E. JOHNSON and EVELYN M. JOHNSON, Trustees of the Johnson Family Trust, Grantees, an undivided one-half interest as tenant in common in the following described real property located in Klamath County, Oregon:

Parcel #1: Lot 1, Block 1, WILLIAMS ADDITION to the City of Klamath Falls, Klamath County, Oregon, also known as 2033 Herbert Street, Klamath Falls, Oregon.

Parcel #2: The East one-half of the Northeast quarter (E $\frac{1}{2}$ NE $\frac{1}{4}$) of Section 32, Township 39 South, Range 9 East of the Willamette Meridian;
