Beginning at a point that is North 00°28'28" West 893.20 feet from the South quarter corner of said Section 27; thence East 903.51 feet, more or less, to the Northwest corner of that parcel conveyed to Warren R. Hargraves by Quit Claim Deed recorded August 12, 1983 in Book M83 of Deeds at Page 13471 of Official Records of Klamath County, Oregon; thence South 312 feet, more or less, to the Southwest corner of said Hargraves parcel; thence West, parallel to the South line of the SE $\frac{1}{4}$ of said Section 27 to the North-South centerline of said Section; thence North along said North-South centerline to the point of beginning.

Said facilities to be placed along and adjacent to an Easterly-Westerly roadway, as it exists, located in the Southerly portion of said described property. It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction.

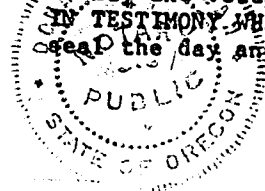
