

ASSIGNMENT FOR SECURITY PURPOSES

This agreement is made between Comtek International, Inc., an Oregon corporation (hereinafter "Comtek"), and Robert L. Anthony and Margaret I. Anthony, husband and wife (hereinafter "Anthony").
