Subject as to the rights of other parties with respect to any of said lands under instruments of record and existing agreements with and permits from Owner.


The terms and conditions of this Easement are as follows:


- 1. Owner shall have the right to use said strip of land for any purpose not inconsistent with the rights herein granted.

- 5. Grantee shall pay for all damages to Owner's property resulting directly or indirectly from the negligent acts or omissions of Grantee hereunder.
- 6. Grantee shall indemnify and hold harmless Owner from all claims for damages which may be caused by Grantee's exercise of rights herein granted.
- 7. The rights herein granted shall continue until such time as Grantee shall have abandoned the use of the cable located as described herein.
