

LAST WILL AND TESTAMENT

OF

RALPH G. HUGO

I, RALPH G. HUGO, residing in the County of Los Angeles, State of California, being of sound and disposing mind and memory and not acting under duress or the undue influence of any person whomsoever, being mindful of the brevity of this life, and having placed my faith and confidence in Jesus Christ my Saviour and Lord, who redeemed my soul through His shed blood and death upon Calvary's Cross for my sins, and who thus assures me of eternal life, do hereby make, publish, and declare this to be my Last Will and Testament, intending thereby to dispose of all property and estate of every kind and nature whatsoever of which I may die possessed or of which I may in any way have the right to dispose wheresoever the same may be located and hereby revoke all former Wills and Codicils to Wills by me made.

FIRST

I declare that I am married and that my wife's name is SHARON HUGO, and that we have two children, namely, SHAWNDA LISE HUGO and SHANNON LEIGH HUGO.

SECOND

I declare that all of the property that I now own has been acquired since my marriage and is, therefore, the community property of myself and my wife.

THIRD

I direct my executor, hereinafter named, to pay all of my just debts, last illness and funeral expenses as soon after my demise as may be lawfully and conveniently done.

FOURTH

A. All of my estate, of whatsoever nature and wheresoever situated, both real and personal, I give, devise and bequeath to my wife, SHARON HUGO.

B. In the event that my wife, SHARON HUGO, should not survive the distribution of my estate, then and in that event all of my estate of whatsoever nature and wheresoever situated, I give, devise and bequeath as follows:

1. Forty-five percent (45%) to SHAWNDA LISE HUGO.
2. Forty-five percent (45%) to SHANNON LEIGH HUGO.
3. Ten percent (10%) to LAKE AVENUE CONGREGATIONAL CHURCH, Pasadena, California.

C. In the event that our entire family, including ourselves and our children, should perish at the same time, or in the event that none of our said family should survive the distribution of our estate, then and in that event I give, devise and bequeath my estate as follows:

1. Fifty percent (50%) to JACK P. HUGO of Klamath Falls, Oregon.
2. Twenty-five percent (25%) to LAKE AVENUE CONGREGATIONAL CHURCH, Pasadena, California
3. Twenty-five percent (25%) to YOUNG LIFE of Colorado Springs, Colorado.

FIFTH

If any beneficiary under this Will in any manner, directly or indirectly, contests or attacks this Will or any of its provisions, any share or interest in my estate given to that contesting beneficiary under this Will is revoked and shall be disposed of in the same manner provided herein as if that contesting beneficiary had predeceased me.

SIXTH

I direct that all inheritance, estate, or other death taxes (excluding any additional tax imposed under Internal Revenue Code section 2032A or any generation-skipping transfer tax) that may by reason of my death be attributable to my probate estate or any portion of it, or to any property or transfers of property outside my probate estate, shall be paid by my Executor out of the residue of my estate disposed of by this Will, without adjustment among the residuary beneficiaries, and shall not be charged against or collected from any beneficiary of my probate estate, or from any transferee or beneficiary of any property outside my probate estate.

SEVENTH

I hereby nominate and appoint my wife, SHARON HUGO, to be the Executor of this my Last Will and Testament, to serve without bond. I authorize my Executor to sell, with or without notice, at either public or private sale, any property or business belonging to my estate that she, in her discretion, deems necessary for the proper administration of my estate. I further authorize my Executor to continue

1 the operation of any business belonging to my estate.


2 In the event that my wife, SHARON HUGO, is unable to or
