THIS DEED made September 14, 1984, between TOM DURYEE, Sheriff of Klamath County, Oregon, hereinafter called Grantor and Klamath First Federal Savings and Loan Association, hereinafter called Grantee.

In a suit in the Circuit Court of the State of Oregon for Klamath County, Oregon in which KLAMATH FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, a Corporation, was Plaintiff and ROBERT THOMAS; ERNEST R. SESSOM; DORIS C. SESSOM, aka DORIS SESSOM; STATE OF OREGON, DEPARTMENT OF REVENUE; DAVID DREW, dba Shaw Stationery Co.; STATE OF OREGON, EMPLOYMENT DIVISION; SOUTH VALLEY STATE BANK, an Oregon Corporation; UNITED STATES OF AMERICA; E BEVERLY LEWIS, dba Lewis Arco; JOSEPH PAUL SABO; MARY SABO; OREGON STATE BAR; STATE ACCIDENT INSURANCE FUND CORPORATION; FRANCES DENNIS; CARTER-JONES COLLECTION SERVICE, INC., an Oregon Corporation; RICHARD W.
