This is to certify that I am the Oregon State Director of the Farmers Home Administration for the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, beneficiary in that certain deed of trust in which Cheryl D. Cordova, as grantor(s), conveyed to the Farmers Home Administration, United States Department of Agriculture, acting through the State Director of the Farmers Home Administration for the State of Oregon, as trustee, certain real property in Klamath County, Oregon, to secure the performance by said grantor(s) of certain obligations; said deed of trust was dated December 4, 1981, and recorded December 4, 1981, in Volume No. M81, Page 20943, records of said county; thereafter and on March 29, 1984, there was recorded in Volume No. M84, Page 4950 of said records the beneficiary's notice of default with respect to the performance of the obligations secured by said deed of trust; thereafter the said deed of trust was duly foreclosed by advertisement and sale and the real property covered by said trust deed was sold at the trustee's sale on September 6, 1984 and at no time during the period of three months and one day immediately preceding the day of said sale, and including the day thereof, was the real property described in and covered by said trust deed, or an interest therein, owned by a person in the military service of the United States as such term is defined by the Soldiers' and Sailors' Civil Relief Act of 1940 approved October 17, 1940, as subsequently amended, nor during said period was such person ordered to report for induction into the said military service, nor was he serving with the forces of any nation allied with the United States in the prosecution of any war in which the United States was or is engaged.

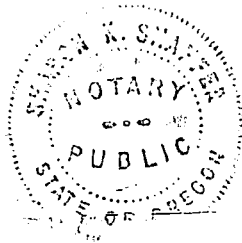
