## TRUSTEE'S DEED

THIS INDENTURE, made this 24th day of September , 19 between the Farmers Home Administration, United States Department of Agriculture, acting through the State Director of the Farmers Home Administration for the State of Oregon, hereafter called trustee, and the United States of America, acting through the Farmers Home Administration, hereafter called the second party:

## RECITALS:

Cheryl D. Cordova, as grantor(s), executed and delivered to the Farmers Home Administration, United States Department of Agriculture, acting through the State Director of the Farmers Home Administration for the State of Oregon, as trustee, for the benefit of the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, as beneficiary, a certain trust deed dated December 4, 1981, and recorded December 4, 1981, in Volume M81, page 20943 of Mortgages, records of Klamath County, Oregon. In and by said trust deed the real property therein and hereafter described was conveyed by said grantor(s) to said trustee to secure, among other things, the performance of certain obligations of the grantor(s) to the said beneficiary as set forth in said trust deed. thereafter defaulted in their performance of the obligations secured by said trust deed as stated in the notice of default hereafter mentioned and such default still existed at the time of the sale hereafter described.

By reason of said default, the owner and holder of the obligations secured by said trust deed, being the beneficiary named in said trust deed, or his successor in interest, declared all sums secured by said trust deed immediately due and owing; a notice of said default, containing an election to sell the said real property and to foreclose said trust deed by advertisement and sale to satisfy the obligations of the grantor(s) aforesaid was recorded in the records of said county on March 29, 1984, in Mortgages, volume M84 at page 4950, to which reference is now made.

After the recording of said notice of default, as aforesaid, the undersigned trustee gave notice of the time for and place of sale of said real property as fixed by him and as required by law; copies of the trustee's said notice of sale were mailed by U. S. registered or certified mail to all persons entitled by law to such notice at their respective last known addresses; the persons named in subsection 1 of Section 86.750 were timely personally served with said notice of sale, all as provided by law and at least 120 days before the day so fixed for said trustee's sale: Further, the trustee published a copy of said notice of sale in a newspaper of general circulation in each county in which the said real property is situated, once a week for four successive weeks, the last publication of said notice occurred at least twenty days prior to the date of such sale. The mailing, service and publication of said notice of sale are shown by one or more affidavits of proofs of service duly recorded prior to the date of sale in the mortgage records of said county, said affidavits and proofs, together with the said notice of default and election to sell and the trustee's notice of sale, being now referred to and incorporated in and made a part of this trustee's deed as fully as if set out herein verbatim. On the date of said notice of sale, the undersigned trustee had no actual notice of any person, other than the persons named in said affidavits and proofs having or claiming a lien on or interest in said described real property subsequent to the interest of the trustee in the trust deed.
