THIS AGREEMENT is made between LOETTA M. WOODS and LOHREE K. HORSWILL, hereinafter referred to as Lender, and WILLIAM T. JOHNSON and DOLORES Y. JOHNSON, hereinafter referred to as Borrower.

WHEREAS Borrower executed and delivered a Note and Trust Deed dated February 22, 1979, recorded October 1, 1980, in Book M80, Page 18942, on the subject real property described as:

> Lot 20 in Block 7 OREGON SHORES SUBDIVISION - Tract #1053, in the County of Klamath, State of Oregon, as shown on the Map filed on October 3, 1973, in Volume 20, Pages 21 and 22 of MAPS in the office of the County Recorder of said County.

which Trust Deed was subsequently assigned to Lender; and

WHEREAS Borrower is in default under said Trust Deed and has failed to pay all real property taxes when due and to make the monthly payments due for December 18, 1983, and each month thereafter; and

WHEREAS there is currently owing to Lender thereon the sum of \$972.75 with interest at the rate of 7% per annum from March 1, 1984; Borrower covenants that said amount is a valid debt with no defenses, offsets, or adjustments thereto; and

WHEREAS Borrower desires to modify the terms of said loan; now, therefore

In consideration of the mutual covenants contained herein and in consideration of Lender's forbearance from foreclosure, the parties agree as follows:

1. Real property taxes owing from 1981 through 1984 shall be paid by Lender and shall be added to the balance due, in the sum of \$304.31; and interest owing from March 1, 1984, to August 1, 1984, in the sum of \$28.46 shall be added to the present balance, to make the total balance owed to equal the sum of \$1,305.52 with interest current to August 1, 1984.

2. The interest rate shall be increased from 7% per annum to 12% per annum, effective August 1, 1984.

3. The next monthly payment shall be due on September 1, 1984, and shall be due on the 1st day of each month thereafter.
