Traviss, plain-8 9 tiffs' petition for provisional process and the complaint on the underlying claim filed by the plaintiffs, the court finds 10 that there is probable cause for sustaining the validity of the 11 12 underlying claim, and that the underlying claim is not based 13 upon a consumer transaction and that attachment is not sought for a consumer good but rather for attachment by claim of lien 14 on real property owned by defendants Steven D.
