hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Parcel I: All that portion of the Northwest Quarter of the Northwest Quarter of Section Thirty-one (31), Township Twenty-four (24) South, Range Nine (9) EWM., lying on the Westerly side of the Klamath Northern Railroad Company's right-of-way through said Northwest Quarter of the Northwest Quarter of Section Thirty-one (31), above stated.

Parcel II: Beginning at the corner common to Sections 25 and 36, Township 24 S., Range 8 EWM, and Sections 30 and 31, Township 24 S., Range 9 EWM; thence North 89°50'17" West 210.0 feet along the line between said Sections 25 and 36; thence South 0°39' West 541.94 feet to the Northwesterly right-of-way line of the Klamath-Northern Railroad; thence North 39°37' East 333.91 feet along said right-of-way line to the Section line between Section 36, Township 24 S., Range 8 EWM, and Section 31, Township 24 S., Range 9 EWM; thence along said Section line North 0°39' East 284.12 feet, more or less, to the point of beginning.
