Parcel I: All that portion of the Northwest Quarter of the Northwest Quarter of Section Thirty-One (31), Township Twenty-four (24) South, Range Nine (9) EWM., lying on the Westerly side of the Klamath Northern Railroad Company's right-of-way through said Northwest Quarter of the Northwest Quarter of Section Thirty-one (31), above stated.
