KNOW ALL MEN BY THESE PRESENTS, That W. Alan Bowker and Lenis Bowker, husband and wife, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Dale O. Woods and Karen A. Woods, husband and wife hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land situated in Tract 2A "HOMEDALE" Subdivision in Section 11, Township 39 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, being more particularly described as follows:
