**ORDER FOR MEETING OF CREDITORS AND FIXING TIMES FOR FILING
OBJECTIONS TO DISCHARGE AND FOR FILING COMPLAINTS TO DETERMINE
DISCHARGEABILITY OF CERTAIN DEBTS, COMBINED WITH NOTICE THEREOF
AND OF AUTOMATIC STAY**

To the debtor, his creditors, and other parties in interest:

An order for relief under 11 U.S.C. chapter 7 having been entered on a petition filed by (or against) RUSS R. RAMOS and DANITA S. RAMOS of 5224 Primrose Lane, Klamath Falls, Oregon 97601 on October 4, 1984, it is ordered, and notice is hereby given, that

1. A meeting of creditors pursuant to 11 U.S.C. §341(a) has been scheduled for the 14th day of November, 1984, at 11:10 o'clock a. m. at Commissioners Hearing Room, Second Floor, Courthouse Annex, Main Street, Klamath Falls, Oregon.

2. The debtor shall appear in person (or, if the debtor is a partnership, by a general partner, or, if the debtor is a corporation, by its president or other executive officer) at the time and place for the purpose of being examined.

3. [If the debtor is an individual] January 14, 1985, fixed as the last day for the filing of objections to the discharge of the debtor pursuant to 11 U.S.C. §727.

4. [If the debtor is an individual] January 14, 1985, fixed as the last day for the filing of a complaint to determine the dischargeability of a debt pursuant to 11 U.S.C. §523(c).

You are further notified that

The meeting may be continued or adjourned from time to time by notice at the meeting, without further written notice to creditors.

At the meeting the creditors may file their claims, elect a trustee as permitted by law, [if appropriate designate a person to supervise the meeting, elect a committee of creditors], examine the debtor, and transact such other business as may properly come before the meeting.

As a result of the filing of the petition, certain acts and proceedings against the debtor and his property are stayed as provided in 11 U.S.C. §362(a).

[If the debtor is an individual] If no objection to the discharge of the debtor is filed on or before the last day fixed therefor as stated in subparagraph 3 above, the debtor will be granted his discharge. If no complaint to determine the dischargeability of a debt under clause (2), (4), or (6) of 11 U.S.C. §523(a) is filed within the time fixed thereof as stated in subparagraph 4 above, the debt may be discharged.

In order to have his claim allowed so that he may share in any distribution from the estate, a creditor must file a claim, whether or not he is included in the list of creditors filed by the debtor. Claims which are not filed within 90 days after the above date set for the meeting of creditors will not be allowed, except as otherwise provided by law. A claim may be filed in the office of the clerk of the bankruptcy court at address below

on or before February 13, 1985

Unless the court extends the time, any objection to the debtor's claim of exempt property (Schedule B-4) must be filed within 30 days after the conclusion of the meeting of creditors. If you wish copies there are 4 pages of Schedules A-2 & A-3. If you desire copies make check payable to Clerk, U.S. Bankruptcy Court, P.O. Box 1335 Eugene, Oregon 97440 and enclose a self-addressed, stamped envelope.
