EASEMENT FOR BURIED CABLE

WEYERHAEUSER COMPANY, a Washington corporation, herein called "Owner," hereby grants to PACIFIC POWER & LIGHT COMPANY, a corporation, herein called "Grantee," an easement ten (10) feet in width for an underground electric cable across a portion of the S.W. 1/4 of Section 17, Township 39 South, Range 3 East, W.M., Klamath County, Oregon, the centerline of said 10 foot easement to be located approximately as shown in red on the attached Exhibit A.

Subject as to said lands to all matters of public record.

The terms and conditions of this Easement are as follows:

1. Owner shall have the right to use said strip of land for any purpose not inconsistent with the rights herein granted.
2. Grantee shall have access to the cable for the purpose of exercising the rights herein granted.
3. The electric cable is to be buried at a minimum depth of thirty-six (36) inches and is to be clearly marked by the placement of intervisible markers.
4. Grantee hereby waives all claims for damages to its cable which may result from or arise out of Owner's normal operations.
5. Grantee shall pay for all damages to Owner's property resulting directly or indirectly from the negligent acts or omissions of Grantee hereunder.
6. Grantee shall indemnify and hold harmless Owner from all claims for damages which may be caused by Grantee's exercise of rights herein granted.
7. The rights herein granted shall continue until such time as Grantee shall have abandoned the use of the cable located as described herein.


