Know all Men by These Presents: That I, ORVAL LEE LONDON, also known as O. L. LONDON,

have made, constituted and appointed, and by these presents do hereby make, constitute and appoint my wife, DORENE LONDON

Giving and Granting unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, all that my said attorney hereby ratifying and confirming shall lawfully do or cause to be done by virtue of these presents.
