DECLARATION OF ABSOLUTE NATURAL INDIVIDUAL STATUS, AND

7 Social Security Number, and/or any other such Certificates,

11 REVOKED.

17 Absolute Natural Individual, Gregg Al Cramblet, at 325 North 6th
18 Street, Klamath Falls, Oregon, 97601, within 20 (twenty) days,
19 or such Power shall be NULL and VOID.

20 WHEREUPON; the aforescribed Notice and/or information
21 shall be given, Gregg Al Cramblet shall have a Right to sufficient
22 time to correct such defect and to Cancel and Revoke any such
23 Power.

24 IT IS HEREBY REAFFIRMED; that this Absolute Natural Individ-
25 ual, is Governed only by the "DECLARATION OF INDEPENDENCE", in
26 Congress, July 4, 1776, and by the UNITED STATES (of America)
27 CONSTITUTION, ARTICLES I THROUGH VII, exclusively, and that
28 Gregg Al Cramblet is an "ABSOLUTE NATURAL INDIVIDUAL" as intended
29 by the Framers of the Constitution, and under the "LAW OF NATIONS"

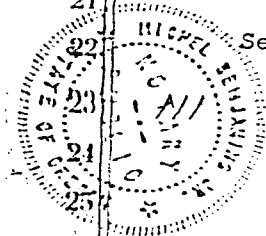
