Any and all other uses from the birth certificate, whether unknowingly or knowingly, by my own actions or through another, either expressed or implied, are hereby revoked, cancelled, rescinded, removed, etc. by this Revocation of Power. This document supercedes any previous document not in conformity with the terms hereof.

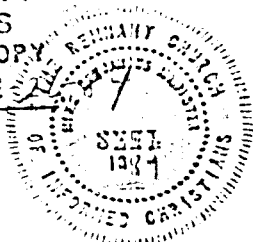
