MEMORANDUM OF CONTRACT

KNOW ALL MEN BY THESE PRESENTS, that on the 27th day of December, 1984,  
LARRY S. FISH, as seller, and DONALD H. KARSCH, as purchaser, entered into a con-  
tract of sale for the following-described real property situated in Klamath  
County, Oregon, to-wit:

A tract of land located in the SE1/4 of Section 22, Township 39 South,  
Range 8 East of the Willamette Meridian, in the County of Klamath, State  
of Oregon, and more particularly described as follows:  
Beginning at the quarter corner common to Sections 22 and 23, said cor-  
ner being a 1/2" iron pin, thence North 00°12'35" East along the section  
line between Sections 22 and 23, 603.0 feet to a 3/4" iron pin and the  
true point of beginning; thence South 89°25'01" West, 563.81 feet to a  
3/4" iron pin; thence North 14°44' West, 722.0 feet to a 3/4" iron pin; thence South  
00°12'35" West along the section line between Sections 22 and 23, 700.0  
feet to the true point of beginning, said parcel containing 10.56 acres,

TOGETHER WITH an easement for ingress and egress.

The purchaser in said contract agreed to pay seller the sum of \$2,558.00,  
plus other consideration, for said real property, and said sum is the true and  
actual consideration for said sale.

This memorandum is not a complete summary of the contract of sale. Provi-  
sions in the memorandum shall not be used in interpreting the contract provisions.  
In the event of a conflict between the memorandum and the unrecorded contract,  
the unrecorded contract shall control.
