Figure 1 is a schematic representation of the experimental design. It shows a sequence of steps: 1. Baseline (no stimulus), 2. Stimulus (light), 3. Response (eye movement), 4. Feedback (light), 5. Response (eye movement), 6. Feedback (light). The sequence is repeated for multiple trials.
