Defendant has failed to plead or otherwise defend this action and default has been entered accordingly. Plaintiff has requested judgment by default against defendant and filed an affidavit that defendant owes plaintiff \$2,879.31 plus interest at 8% from July 25, 1980 and \$62.50 plus interest since April 1, 1980, and that defendant is not an infant or incompetent or in the military service of the United States.

IT IS ORDERED that plaintiff recover from defendant \$2,879.31 with interest from July 25, 1980 at 8% per year and \$62.50, with interest from April 1, 1980 at 10.5% per year for a total of ~~\$3,696.72~~ ^{\$3,700.65} plus attorney fees of \$512.09 for a total judgment of ~~\$4,208.81~~ ^{\$4,212.74}.
