I, California S. Taylor do depose and say that John Taylor and I while owning property in the SW $\frac{1}{4}$ , SW $\frac{1}{4}$  of Sect. 33, T. 39 S., R. 9 E. W.M. 1940 to December 1978 when sold to William M. Bond and Marie Bond we had irrigation rights through a ditch and used each year across the adjoining property (under several ownerships) as described as follows:

Beginning at the section Corners 32, 33 and 5, 4 which is the intersection of Midland Road and Tingley Lane Road; thence North to the C-4 lateral; thence Southwesterly along the Southeaster bank to the first check structure and the first turn-out supply gate West of Tingley Lane which is the point of beginning of the irrigation supply ditch; thence Southeasterly approximately 460' as scaled off the aerial photo to the West line of Tingley Lane Road. This irrigation right was transferred by the Deed of Sale to William M. Bond and Marie Bond.

As long as we continue this usage we will do as has been done in the past -- minimum maintenance viz: ditch cleaning and bank building to insure delivery of water through it to our property with the mutual agreement with the current property owner. We feel according to our deed and action we have a very current water right and will defend it with appropriate legal action if necessary in the future.
