DECLARATION OF ABSOLUTE NATURAL INDIVIDUAL STATUS

REVOCATION OF UNWITTINGLY PARTICIPATION IN PUBLIC POLICY

TO ALL THOSE TO WHOM THESE PRESENTS SHALL COME, GREETING:

, do hereby declare that I am not the property of the UNITED STATES TREASURY for security and/or collateral purposes of the federal Reserve or for any other reason(s).

I, Clarence Wesley Byers

, do further declare that the Power of all known and/or unknown devices such as and including: Birth Certificate/Registration, Marriage License(s), Bank Account(s), Mortgage(s), Loan(s), Social Security Number(s), and/or any other such certificates, registrations, or licenses which do/did bring this Absolute Natural Individual, unknowingly or otherwise, to be a member, participant or part of the CESTUI QUE federal Public Policy (Charitable) Trust is hereby and the same is forever revoked.

For the purposes of this instrument, "revoked" shall be construed as "revoked" in its common usage, and: cancelled, rescinded, removed, and nullified.

Any Public Official or any other person in any capacity whatsoever having knowledge of any other power and/or device which should and/or must be revoked and/or added to this Declaration, in order to fully facilitate and fulfill the intent of this document, must supply notice of such to:

within twenty (20) days, or such power shall be NULL and VOID. Whereupon, the aforescribed notice and/or information shall be given, said Declarator shall have a right to sufficient time to correct such defect and to cancel and revoke any such power.

IT IS, HEREBY, REAFFIRMED that this ABSOLUTE NATURAL INDIVIDUAL,

Clarence Wesley Byers

, is governed only by the DECLARATION OF INDEPENDENCE, in Congress, July 4th, 1776, and recognizes the UNITED STATES (of America) Organic Constitution, Articles I through VII (as these Articles amend the Declaration of Independence) which provide for the Government: "a NATIONAL REPUBLIC", exclusively, and that Declarator herein is an ABSOLUTE NATURAL INDIVIDUAL as intended by the Framers of the Organic Constitution which is an ordinance within and under the LAW OF NATIONS, the Law of Nature, Rights of Conscience, and the Law of ALMIGHTY GOD.

WHEREAS, unwittingly and unwillingly, by me and/or actions of deceit of Public Servants, my rights as guaranteed by the aforementioned documents have been cruelly violated and usurped by the Cestui Que federal Public Policy (Charitable) Trust, I do now hereby revoke and repudiate any such association or power of such over me, an ABSOLUTE NATURAL INDIVIDUAL and/or property(ies), and do proclaim under GOD ALMIGHTY, in accordance with the Founders of this Nation under God, this Declaration of Absolute Natural Individual Status

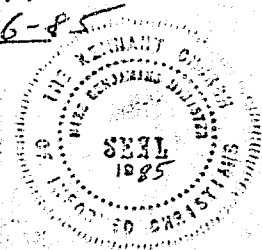
