NOTICE OF ADOPTION OF AMENDED RULE 274-21-005

DIVISION 21

FORECLOSED AND DEEDED PROPERTY

Foreclosed and Deeded Property

274-21-005 Properties acquired under LORS 407.0807 ORS 407.135 and \angle 407.090(1)7 $\underline{407.145(1)}$ when initially offered for sale will be under the following terms:

- (1) Must be offered first by sealed bid.
- (2) Must be advertised in the local newspaper and comply with the following:
- (a) Published at least once during the 30 days prior to the bid opening;
- (b) Advise prospective buyers of the eligible veterans' preference on the bid.
 - (3) Interest rates:
- (a) An eligible veteran may choose the same interest rate that was charged on the loan when the property became state-owned, and it will be variable but cannot increase more than one percent except when necessary to maintain the solvency of the Department of Veterans' Affairs:7.

- (b) The interest rate charged to nonveterans, and to veterans who do not choose the "eligible veterans" interest rate under the provisions of subsection (3)(a) of this rule, shall be nine percent. The rate will be variable, but cannot increase more than one percent except when necessary to maintain the solvency of the Department of Veterans' Affairs7;
- (c) When the property is transferred from the original purchaser, or from any subsequent purchaser, to anyone (veteran or nonveteran), other than the surviving spouse, unremarried former spouse, surviving child, or surviving stepchild of the purchaser, the interest rate from the date of <code>[each]</code> such transfer shall be the same as the then-prevailing interest rate under subsection (3)(b) of this rule.
- (4) Each property will be sold on contract and the terms will be as follows:
 - (a) Length:
- (A) The length of the contract will be established by the purchase price, as follows:

 - (iii) \$20,000 \$34,999.99......20 years;

 - (v) \$10,000 \$14,999.99......10 years;
 - (vi) \$ 5,000 \$ 9,999.99......7 years;
 - (vii) Under \$5,000......5 years.
- (B) The Director may enter into a contract with a length different from that prescribed in this rule if it is found that failure to do so would result in serious harm to one of the parties to the contract.
