11. Transfer by Mortgagor.

15. Rights and Remedies on Default.

15.1 Upon the occurrence of any event of default and at any time thereafter, the Lender may exercise any one or more of the following rights and remedies:

- (a) The right at its option by notice to Borrower to declare the entire Indebtedness immediately due and payable.
- (b) With respect to all or any part of the Property that constitutes realty, the right to foreclose by judicial foreclosure in accordance with applicable law

- (e) The right in connection with any legal proceedings to have a receiver appointed to take possession of any or all of the Property, with the power to protect and preserve the Properly and to operate the Property preceding foreclosure or sale and apply the proceeds, over and above cost of the receiver-ship, against the Indebtedness. The receiver may serve without bond if permitted by law.
