GENERAL POWER OF ATTORNEY

Generally to conduct, manage and control all of my business and property, wheresoever situated and of whatsoever nature, as my said attorney may deem for my best interest hereby releasing all third persons from responsibility for the acts and omissions of my said attorney WILLIAM THOMAS CROWDER. I hereby give and grant unto WILLIAM THOMAS CROWDER full power and authority freely to do and perform every act and thing whatsoever as fully to all intents and purposes I might or could do if personally present hereby ratifying and confirming all that my said attorney in fact shall lawfully do or cause to be done by virtue hereof.
