SHERIFF'S DEED

THIS DEED made <u>January 22</u>, 1985, between TOM DURYEE, Sheriff of Klamath County, Oregon, hereinafter called Grantor and VERA L. POULSEN, hereinafter called Grantee

WITNESSETH:

WHEREAS, in a suit in the Circuit Court of the State of Oregon, for Klamath County, Oregon, between VERA L. POULSEN, Plaintiff, and ROBERT W. ANDERSON aka ROBERT WAYNE ANDERSON, aka WAYNE ANDERSON, and DARLENE ANDERSON, husband and wife, Defendants, a judgment was entered on November 30, 1983, for the foreclosure of a mortgage on the real property described below; and

WHEREAS, the Court thereafter issued a writ of execution and pursuant thereto on January 23, 1984, all of the interest of the defendants in the real property was sold at public auction, subject to redemption, in the manner provided by law, for the sum of \$31,395.00, to VERA L.
