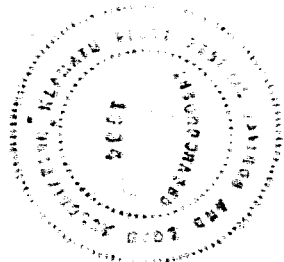
## SATISFACTION OF MORTGAGE
