POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, RUTH E. HOLCOMB, a resident of the City of Klamath Falls, County of Klamath, State of Oregon, have made, constituted and appointed, and by these presents do make, constitute and appoint my niece, NOLA MATTHEWS, a resident of the City of Tucson, County of Pima, State of Arizona, my true and lawful attorney-in-fact for me and in my name, place and stead, and on my behalf, and for my use and benefit, to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever as are now, or shall hereafter become, due, owing, payable or belonging to me, and have, use and take all lawful ways and means in my name, or otherwise, for the recovery thereof, by attachments, arrests, distress or otherwise, and to compromise and agree for the same, acquittances, or other sufficient discharges for the same, for me, and in my name, to make, seal and deliver; to bargain, contract, agree for, purchase, receive, and take lands, tenements, hereditaments and accept the seisin and possession of all lands and all deeds and other assurances, in the law therefor, and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions and under such covenants, as she shall think fit. Also, to buy, sell and trade in any stocks, bonds, options or other securities and contracts relating thereto; to bargain and agree for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares, and merchandise, choses in action and other property in possession or in action, and to make, do and transact all and every kind of business of what nature or kind soever, and also for me and in my name, and as my act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignment of leases, covenants, indentures, agreements, mortgages, hypothecations, bottomries, charter parties, bills of lading, bills, bonds, notes, receipts, evidences of debts, releases and satisfactions of mortgage, judgments and other debts, and such other instruments in writing of whatever kind and nature as may be necessary or proper in the premises:

 12 revocation, hereby ratifying and confirming all that my said attorney, or her  
 13 substitute or substitutes, shall lawfully do or cause to be done by virtue of  
 14 these presents.

15 This power of attorney shall not be affected by my later disability or in-  
 16 competence or uncertainty as to whether I am dead or alive and all acts done by  
 17 my attorney-in-fact pursuant to this power during any period of disability or  
 18 incompetence or uncertainty as to whether I am dead or alive shall have the same  
 19 effect and inure to the benefit of and bind me, my heirs, legatees, devisees  
 20 and personal representative as if I were alive, competent or not disabled.
