TRANSAMERICA TITLE INSURANCE COMPANY, An Oregon Corporation, as grantor, to  
in favor of WELLS FARGO REALTY SERVICES, INC., An Oregon Corporation, as trustee,  
dated April 17, 1978, recorded May 23, 1978, in the mortgage records of  
Klamath County, Oregon, in book trust instrument No. M-78 at page 10783,  
feeling the force and effect of the foregoing ~~trust instrument~~ (indicate which), covering the following described real  
property situated in said county and state, to-wit:

Lot 11, Block 21, Tract No. 1113, OREGON SHORES UNIT #2, in the  
County of Klamath, State of Oregon.

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured  
by said trust deed and a notice of default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes;  
the default for which the foreclosure is made is grantor's failure to pay when due the following sums:  
Monthly installments of principal and interest due for the months of February,  
March, April, May, June, July, August, and September of 1984, in the amounts of  
\$66.79 each; and subsequent installments of like amounts; Subsequent amounts for  
assessments due under the terms and provisions of the Note and Trust Deed.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust  
deed immediately due and payable, said sums being the following, to-wit:  
\$3,391.44 plus interest and late charges, thereon from January 2, 1984, at the rate  
of EIGHT (8%) PERCENT per annum until paid and all sums expended by the Beneficiary

gation, the performance of which is secured by said trust deed, and the words "trustee" and "beneficiary" include their
