EASEMENT

WE, John W. Patton and Harry W. Patton, hereinafter Grantors, do hereby create an easement upon our property located in Klamath County, Oregon, more particularly described as:

> NW 1/4, SW 1/4, NW 1/4 portion West of railroad tracts, Section 16, Township 28 South, Range 8 East, of the Williamette Meridian.

Said easement is for a 14 foot roadway to run parallel to the East boundary of said described property starting 10 feet from the East boundary of said property. This easement is granted to Gary L. Burbank and Ruth M. Burbank, hereinafter Grantees, and their heirs and assigns. The easement shall be binding upon Grantors, heirs and assigns and shall run with the land hereinafter described in perpetuity. This easement is restricted to the use of the Grantees and Grantors or their heirs and assigns.

The consideration for this easement is the building of a road upon the easement by the Grantees at the Grantees' expense with the Grantees having permission to remove all trees and brush necessary to prepare such a roadway. The Grantee shall bear all costs and provide all labor and materials in preparing said road and shall keep said road free of snow until such time as the Grantors' property is inhabited, at which time an agreement
