Beginning at a point on the West line of said NE $\frac{1}{4}$ of the SW $\frac{1}{4}$, said point being South 89°58'36" East 1319.48 feet and South 00°17'46" West 511.68 feet from the West 1/4 corner of said Section 29; thence South 00°17'46" West along the West line of said NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ 313.63 feet; thence North 73°20'20" East 1232.38 feet; thence North 16°39'40" West 300.00 feet; thence South 73°20'20" West 1140.91 feet to the point of beginning.
