DESCRIPTION OF PROPERTY

The following described real property situate in Klamath County, Oregon:

A tract of land situated in the SW¹ of Section 13, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a 5/8 inch iron pin marking the intersection of the Northerly right of way line of Airway Drive and the Northwesterly right of way line of the U.S.B.R. G-3 lateral, from which the S¹ corner of said section 13 bears S. 16°24'04" W. a distance of 31.42 feet and N. 89°05'04" E. a distance of 365.84 feet; thence S. 89°05'04" W. along the Northerly right of way line of said Airway Drive 279.15 feet to a 5/8 inch iron pin; thence N. 01°03'51" E. 265.29 feet to a 5/8 inch iron pin; thence S. 89°44'07" E. 492.24 feet to a 5/8 inch iron pin on the Northwesterly right of way line of said U.S.B.R. G lateral; thence S. 00°02'21" W. along said Westerly right of way line, 187.54 feet to a 5/8 inch iron pin marking the Northeast corner of Deed Volume M69 page 6193 - Parcel 1 exception, as recorded in the Klamath County Deed records; thence along the Northerly line of said Deed Volume M69 page 6193 - Parcel 1 exception, S. 89°05'04" W. 171.96 feet to a point on the Southeasterly right of way line of said lateral G-3; thence continuing S. 89°05'04" W. 41.06 feet to a 5/8 inch iron pin on the Northwesterly right of way line of said G-3 lateral; thence following said Northwesterly right of way line, S. 42°09'04" W. 128.65 feet, to a 5/8 inch iron pin, and S. 16°24'04" W. 27.23 feet to the point of beginning, containing 2.77 acres, more or less, including the area in said U.S.B.R.
