together with the debt thereby secured, is fully paid, satisfied and discharged.

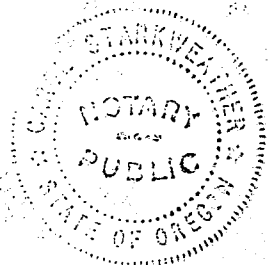
