INTERCHANGE DEED

Marlin D. Wilson and Rosa F. Wilson, husband and wife, Grantors, for and in consideration of an interchange of land under the provisions of the Act of January 12, 1983 (P.L. 97-465; 96 Stat. 2535), which is approximate value to the land herein conveyed, the receipt of which is hereby acknowledged, conveys to the UNITED STATES OF AMERICA, Grantee, and its assigns, all of the real property situated in the County of Klamath, State of Oregon described as follows:

T. 37 S., R. 11-1/2 E., W.M.
Section 5; portion of Lot 9 and the N1/2 of Lot 10 described as follows:

Beginning at the northwest corner of Government Lot 9 (W1/16 corner), section 5, T. 37 S., R. 11-1/2 E., W.M.; thence S 00° 28' 00" W 1268.40 feet to the southwest corner of the N1/2 of Government Lot 10; thence S 89° 36' 37" E 220.00 feet; thence N 00° 27' 59" E 1266.82 feet to the north line of said Government Lot 9; thence N 89° 11' 43" W 220.00 feet to the point of beginning.

Containing 6.4 acres, more or less, according to a plat entitled "Map of Survey, Winema National Forest, Chiloquin Ranger District Township 37 South, Range 11-1/2 East, W.M., Klamath County, Oregon", dated January 27, 1985, a reduced copy attached hereto as Exhibit A and made a part hereof.

Subject to:

1. Rights of the public in and to any portion of the herein described premises lying within the limits of streets, roads or highways.
2. Subject to reservations, restrictions and easement, including the terms and provisions thereof, wherein United States of America is grantor and Esther Tupper Wilson, grantee, recorded in Volume 292 at page 144, Deed Records of Klamath County, Oregon.

The acquiring agency is the Forest Service, Department of Agriculture.

Grantors covenant that they are the owners of the above designated property free of all encumbrances and will warrant and defend the same against all persons who may lawfully claim the same.

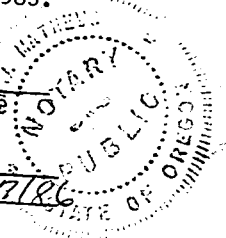

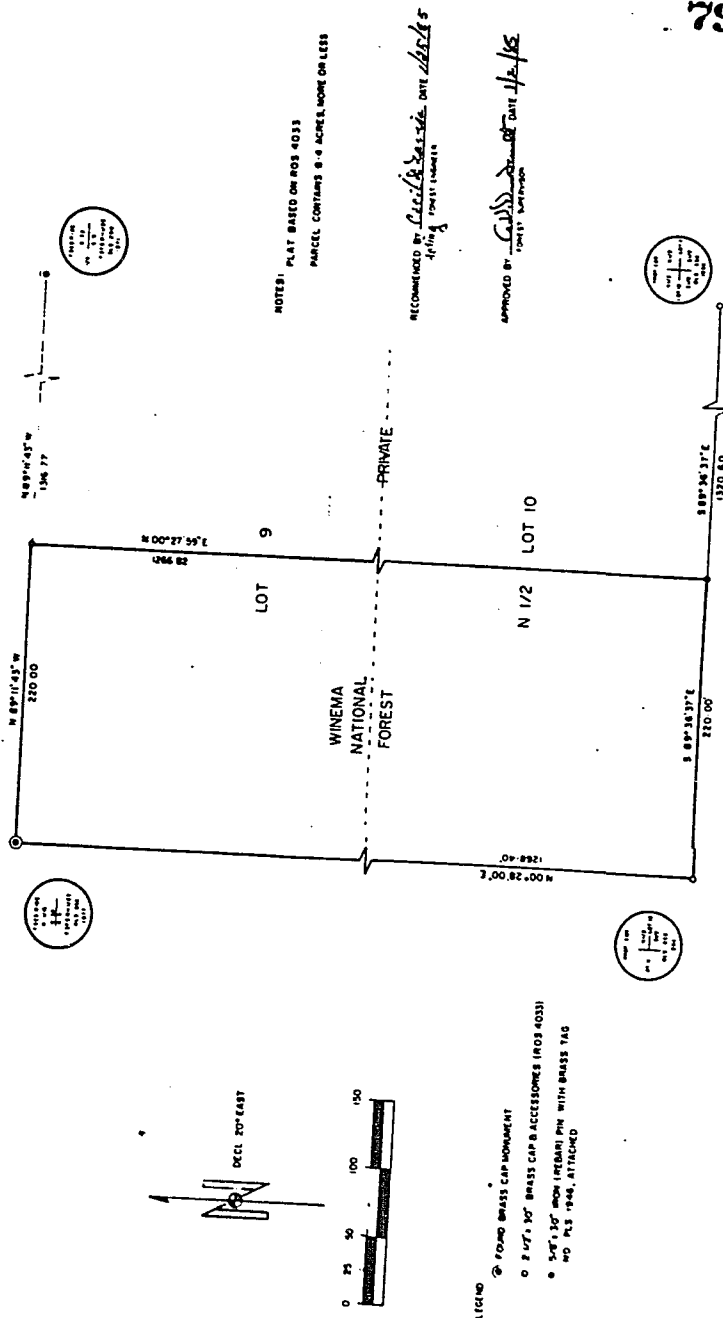
