Plaintiffs shalls satisfy the judgment entered against them in favor of Carter Jones Collection Service on September 22, 1981, which is registered in Klamath County District Court, Case No. DC81-715L, and entered in the Klamath County judgment rolls at Book 37, Page 147, Line 4, in the amount of \$190.50. Defendants shall have the right to pay that judgment for Plaintiffs and to apply any amounts paid on that account as for Plaintiffs and to apply any amounts paid on that account as partial satisfaction of Plaintiffs' obligation under provision 6 Plaintiffs are granted judgment against Defendants for \$3,000.00.
