KNOW ALL MEN BY THESE PRESENTS that the undersigned Richard J. Meeker does hereby relinquish, renounce, disclaim, sell, assign, transfer and set over unto Dorothy Orr, formerly Dorothy Meeker, William Davis Meeker and Nora Myrl Henry all of the right, title, lien, estate and interest of the said Richard J. Meeker in and to the testamentary trust of Joe Meeker established under the Last Will and Testament of Joe Meeker probated in the Circuit Court of the State of Oregon for Klamath County, distribution of which was made in an Order of said Court dated the 7th day of May, 1965. This relinquishment is made in contemplation of the Said Richard J. Meeker, being the majority interest stockholder, and the president and one of the directors of Meeker Farms, Inc., causing the said corporation to take the necessary steps to redeem the 284½ shares of the stock of Meeker Farms, Inc. now held by the said Joe Meeker Trust, it being understood that certain disputes and differences of opinion have arisen within the family and with the trustees which have made the operation of Meeker Farms, Inc. and the management of the trust difficult. This relinquishment, renunciation, disclaimer and assignment of the interest of Richard J. Meeker in said trust shall be binding upon the said trustees; namely, Dorothy Orr and H. Meeker, William Davis Meeker and Nora Myrl Henry, their issue, their heirs, personal representatives, successors and assigns.
