THIS INDENTURE, Made and entered into this 8th day of Oct. 1956, by and between the UNITED STATES OF AMERICA, Department of the Interior, acting by and through the Area Director of the Portland Area Office of the Bureau of Indian Affairs, pursuant to authority in him vested by the provisions of sections 8 (d) (3) and 17 of the Act of Congress approved August 13, 1954 (68 Stat. 718), the provisions of the Acts of Congress codified as sections 1 and 2 of Title 25, United States Code, and the redelegation of authority designated Amendment 17 to Bureau Order 551, dated January 3, 1956 (21 F.R.222), party of the first part, and Friedman Kirk, party of the second part;

WITNESSETH, That said party of the first part, for and in consideration of the exchange of land of approximately equal value, does hereby grant, bargain, sell and convey unto said party of the second part the following described real estate and premises situated in Klamath County, Oregon, to wit:

> EAST HALF SOUTHWEST QUARTER, WEST HALF SOUTHEAST QUARTER, SECTION SIX, AND NORTH HALF NORTHEAST QUARTER SECTION SEVEN, ALL IN TOWNSHIP THIRTY TWO SOUTH, RANGE EIGHT EAST, WILLAMETTE MERIDIAN, CONTAINING 240.00 ACRES, MORE OR LESS,

together with all the improvements thereon and the appurtenances thereunto belonging.

Title to the above-described property is conveyed subject to any existing easements for public roads and highways, for public utilities, and for railroads and pipe lines, and for any other easements or rights of way of record.
