SPECIAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That  
U.S. BANCORP

for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Jimmie J. Roddy and Maxine A. Roddy, husband and wife hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot 8, Block 76, BUENA VISTA ADDITION TO THE CITY OF KLAMATH FALLS, in the County of Klamath, State of Oregon, TOGETHER WITH that portion of Lot 5, Block 76, BUENA VISTA ADDITION, more particularly described as follows:

Beginning at the corner common to Lots 5, 7 and 8 of Block 76, BUENA VISTA ADDITION TO THE CITY OF KLAMATH FALLS, OREGON and running thence North 37° 23½' East along the Northwestern line of said Lot 5 a distance of 47.24 feet to the Southwesterly line of Last Street; thence along the Southwesterly line of Last Street; South 47° 24' East 5.98 feet; thence South 39° 03' West 41.72 feet; thence North 52° 36½' West 4.70 feet, more or less to the point of beginning.
