We hereby acknowledge and confirm the intent of that Telephone Right-of-Way easement recorded August 3, 1984 in Book M84 of Deeds at Pages 13235 through 13238 of Klamath County Records to include installation, operation and maintenance of buried telephone facilities, and the necessary appurtenances thereto, as shown on Exhibit "A", attached hereto and made part hereof, subject to the following conditions:

1. Buried telephone cable is to be installed to a minimum depth of twenty-four (24) inches below ground surface except where the presence of rock or other obstructions makes it impractical and also except within three (3) feet of above-ground telephone equipment enclosures.
2. Fence enclosures are to be maintained at all times except when entering upon or leaving from the property described in the above referenced Telephone Line Right of Way Easement.
3. Said property shall be restored, as nearly as reasonably possible, to prior conditions in a workmanlike manner.

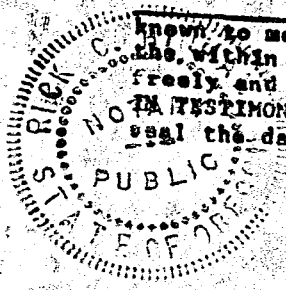

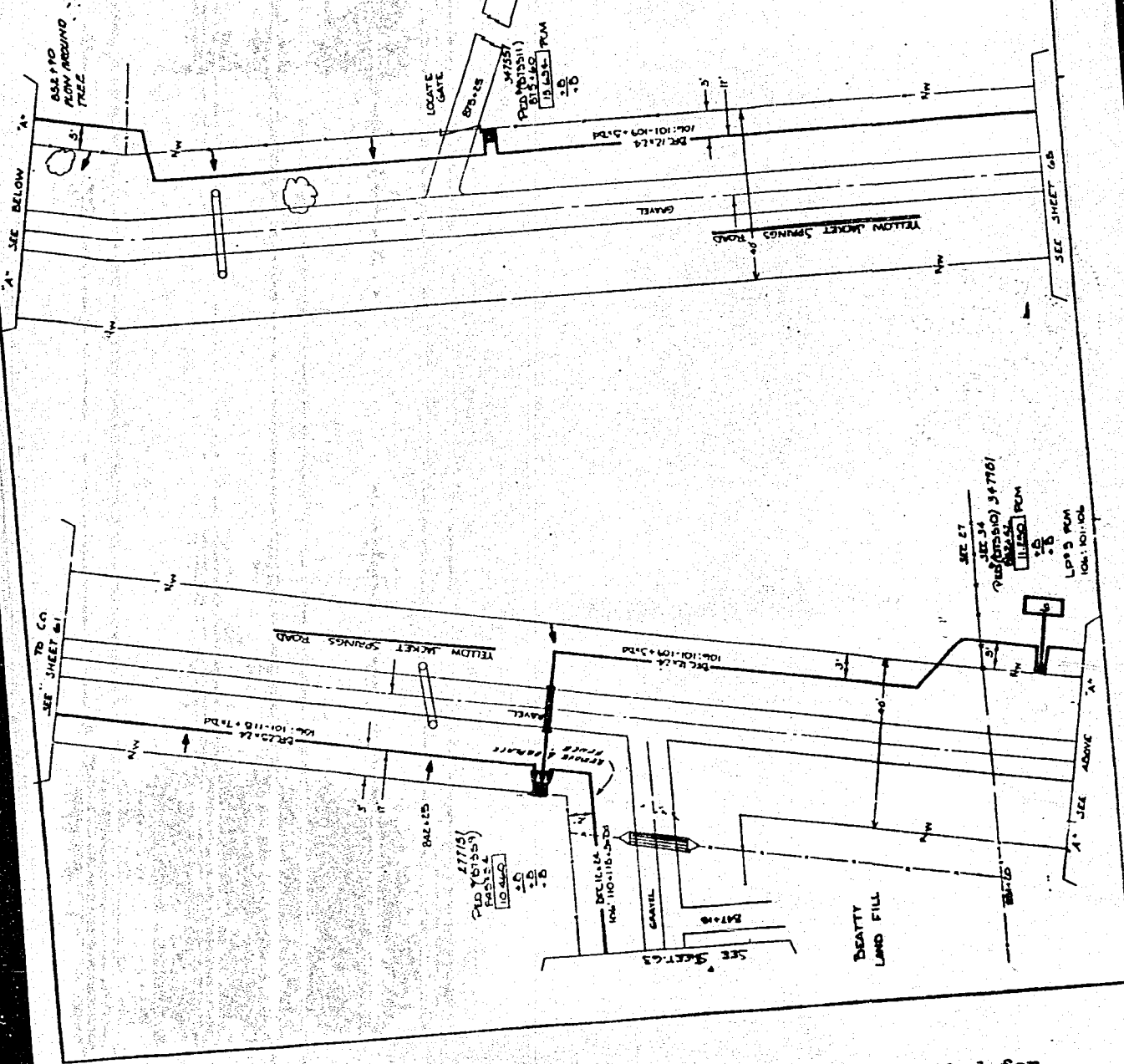
