The undersigned, Grantor, in consideration of \$ _____ and other valuable consideration, hereby grants to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, an easement of right of way for Guy Leads & Anchors (including guys and other supports) at or near the location as now located and staked out by the Grantee over, across and upon the following described real property in Klamath County, State of Oregon, to wit:

A portion of the E $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 5, Township 39 South, Range 9 East, W.M.

Said Guy Leads & Anchors to be located on the above described property as shown on the attached map marked EXHIBIT "A" by this reference made a part hereof.

Together with the right of ingress and egress over the adjacent lands of Grantor for the purpose of construction, reconstruction, maintaining and removing said facilities and exercising the rights hereby granted.

The Grantee shall pay Grantor reasonable compensation for any damage caused by Grantee, or its agents, to any property or crops (growing or to be grown) on the above described property, arising out of the construction, reconstruction or maintenance of said facilities.

All such rights hereunder shall cease if and when such facilities shall have been abandoned.

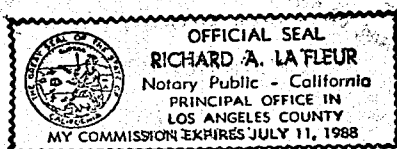
