CONSENT TO EASEMENT

WHEREAS, Klamath County, a political subdivision of the State of Oregon, has a permanent easement to construct, operate and maintain a drainage facility as provided in a Deed dated August 30, 1982, and recorded in Volume M82 at page 12035, Official Records of Klamath County, Oregon; and

WHEREAS, Pape Bros., Inc., an Oregon corporation, on December 10, 1984, executed a Contract and Grant of Easement, granting to the United States a permanent easement for the purpose of operation and maintenance of the 1-G-1 Drain which is a necessary part of the Klamath Irrigation District's drainage system, and is hereinafter described as:

All that portion of the East 20.0 feet of the tract of land described in the Warranty Deed to Pape Bros., Inc., an Oregon corporation, recorded December 20, 1982, in Volume M82 of Deeds at page 18158 of the Official Records of said County. The East line of which is coincident with the West line of the U.S.B.R. 1-G-1 Drain.

NOW, THEREFORE, Klamath County, a political subdivision of the State of Oregon, hereby consents to said Contract and Grant of Easement and hereby subordinates its priority of title to the easement rights granted to the United States by said Contract and Grant of Easement.


